

I, Bonginkosi Emmanuel Nzimande, Minister of Higher Education and Training, hereby, in terms of *Sections 3(4)(l) and 7 of the National Education Policy Act, 1996 (Act No. 27 of 1996)*, read with section 43(1) of the *Further Education and Training Colleges Act, 2006 (Act No 16 of 2006)* approve an amendment of *Paragraph "b" of Schedule 1* and the repeal of paragraph "c" of *Schedule 1* in Government Gazette No 33200, Vol 539, dated 17 May 2010: *Amendment to Government Notice 302 in Government Gazette No 28677, dated 29 March 2006, for the extension of phasing out of the National N Certificates: N1-N3 (Engineering Studies)*, as set out in the **Schedule.**

SCHEDULE

Amendment to the provisions governing the extension of offering of the National N Certificates: N1-N3 (Engineering Studies)

- a) Paragraph (b) of Schedule 1 published in Government Gazette No. 33200 is hereby amended to read as follows:

The extension period shall end after the Minister has, after consultation with the Quality Council for Trades and Occupations (QCTO), determined policy in a published Gazette on:

- i) an occupational qualifications sub-framework as an integral part of the National Qualifications Framework;*
- ii) the sub-framework for quality assurance for occupational qualifications; and*
- iii) any other matter concerning occupational standards or occupational qualifications.*

- b) Paragraph (c) of the Schedule referred to in (a) above is hereby repealed.
