**SKILLS DEVELOPMENT ACT, 1998 (ACT NO. 97 OF 1988) AS AMENDED****AMENDMENT TO GOVERNMENT GAZETTE NO 51625 OF 19 NOVEMBER 2024: CALL FOR NOMINATIONS FOR THE APPOINTMENT OF CHAIRPERSONS OF ACCOUNTING AUTHORITIES FOR ALL SECTOR EDUCATION AND TRAINING AUTHORITIES FOR THE TERM 1 APRIL 2025 TO 31 MARCH 2030**

I, Dr NP Nkabane, Minister of Higher Education and Training, in terms of section 11(1)(b) of the Skills Development Act (Act No. 97 of 1998) as amended, hereby amend the Government Gazette No 51625 of 19 November 2024 inviting nominations for appointment of Chairpersons of the Accounting Authorities for twenty-one (21) Sector Education and Training Authorities.

The previous Government Gazette stated that nominations for the appointment of Chairpersons for all SETA Accounting Authorities must be submitted with proof of specific background checks and verifications. However, considering the deadlines for submitting nominations, it is impractical for nominated candidates to have proof of all necessary checks and verifications ready by the deadline.

In view of the above and to streamline the nomination process, stakeholders in various sectors are kindly informed that **the necessary verification (SAPS Clearance and Qualifications Verifications) will only be finalised at a later date with the suitable candidates identified for an appointment.**

Written nominations from nominating stakeholders indicating full names of organisations nominating and quoting the Ref. No. (in the subject line of the email) must contain the following **Annexures**:

- A - A motivation letter indicating why the nominee must be considered for appointment;
- B - The nominee's signed written acceptance of the nomination;
- C - The nominee's certified copies of qualifications;
- D - The nominee's certified ID copy;
- E - The nominee's curriculum vitae; and
- F - Nominees declaration of interest.
